### INTRODUCTION

On Thursday, May 3, 2012, the 26<sup>th</sup> Legislature of the State of Hawai'i came to a close.

At the final decking deadline of the 2011 Legislative Session, there were a number of bills that did not meet the deadline but had received prior agreement from the subject matter chairs. Some of those bills were acted upon within the first two weeks of the 2012 session. These measures were considered to be "fast tracked" and included two bills that dealt with the University of Hawai'i:

- SB 239 (Act 2) extended the portion of the Hawai'i Tobacco Settlement Special Fund monies allocated for annual operating expenses of the John A. Burns School of Medicine (JABSOM).
- SB 809 (Act 3) increased the University of Hawai'i's authorization to issue revenue bonds by \$100,000,000 for the purpose of financing the construction and maintenance of qualifying capital improvement projects. This measure was re-introduced as part of the 2012 BOR package to reemphasize the importance of this legislation.

Four bills were approved by the University of Hawai'i's Board of Regents (BOR) and introduced as part of the 2012 Governor's package. Two bills did not pass the legislature, which would have extended the exemption granted to the University of Hawai'i from certain provisions of the Hawai'i Procurement Code and authorized the UH to carry over into the next fiscal year up to five percent of the general fund appropriation.

Along with the fast-tracked measures stated earlier, two other bills from the 2012 and 2011 BOR package were also passed:

- HB 2023 (Act 53) makes permanent the assessment and deposit of center for nursing fees into the compliance resolution fund and distribution of those funds to the credit of the center for nursing special fund, passed the legislature.
- SB 240 (Act 186) extended the physician workforce assessment fee and disbursement of the fees collected until 2017.

Other proposals of significance that passed the legislature included:

- SB 1382 (Act 132) requests the Legislative Auditor to examine the federal Higher Education Act of 1965, and make recommendations to ensure compliance of institutions offering post-secondary educational programs.
- SB 243 (Act 137) establishes the Hawai'i Western Interstate Commission of Higher Education (WICHE) and allows Hawai'i WICHE to establish a repayment policy for students who receive financial support from certain funds appropriated for the Hawai'i commission.

For the University System FY13 Supplemental Operating Budget Request, the BOR approved a general fund request of 91 additional FTE positions and \$19.8 million for consideration by the Governor. The Governor's request that was transmitted to the Legislature included 81 additional FTE positions and an increase of \$5.0 million in general funds for the University System.

Although the March 2012 Hawai'i Council on Revenues' projection reflected a slight increase in state general revenue collections for FY12 and FY13, the Legislature maintained a conservative approach in balancing the state operating budget, making limited general fund adjustments to sustain essential state programs. Fortunately, the Legislature did not make cuts to the University's base general fund operating budget as had been occurring since FY09. The Legislature approved one general fund operating budget

adjustment; six additional FTE positions and \$322,242 in general funds for system-wide expansion of Na Pua No'eau, a model program that builds academic capacity of native Hawaiian K-12 students attending Hawaii schools to increase their going rates within the University of Hawai'i system.

HB 2012, HD1, SD1, CD1, amended Act 164, Session Laws of Hawai'i 2011, by adding a total of \$122.931 million to the University of Hawai'i's CIP budget in fiscal year 2012-2013. Of the \$122.931 million, \$121.986 million is in general obligation bonds and \$945,000 is in revenue bonds.

### Highlights include:

- \$15.436 million for Systemwide Health, Safety, and Code Requirements
- \$50.000 million for Systemwide Capital Renewal and Deferred Maintenance
- \$12.500 million for the Pacific Health Research Laboratory
- \$10.000 million for Kapi'olani Community College's Culinary Institute of the Pacific
- \$7.500 million for West Hawai'i Community College at Palamanui

# HB 1617 HD2 SD2 CD1 RELATING TO PUBLIC LANDS

Vetoed (07/10/12)

Establishes provisions relating to commercial, hotel, resort, or industrial leases; extension of term. Allows the board of land and natural resources to extend the lease term of public lands for commercial, hotel or industrial use upon the approval by the board of a development agreement proposed by the lessee or the lessee and developer to make substantial improvements to the demised premises. Requires the lessee, or the lessee and developer to submit to the board the plans and specifications for the total development being proposed. Requires the board to review the specifications and determine whether the development is of sufficient worth and value to justify the extension of the lease; the estimated period of time to complete the improvements and expected date of completion of the improvements; and the minimum revised annual rent based on the fair market value of the lands to be developed, as determined by an appraiser for the board, and percentage rent where gross receipts exceed a specified amount. Prohibits any lease extension until the board and the lessee, or the lessee and the developer, mutually agree to the terms and conditions of the development agreement. Prohibits construction to commence until the lessee, or the lessee and developer have filed with the board a sufficient bond conditioned upon the full and faithful performance of all the terms and conditions of the development agreement. Requires extension of the lease to be based upon the substantial improvements to be made and to be no longer than 55 years. Requires that any extension of a lease granted is to be effectuated, documented, and executed using the

most current lease form and leasing practices and policies of the board. -- Establishes provisions relating to withdrawal of leased land; fair compensation; lease extension. Requires the lease rent to be reduced in proportion to the value of the land withdrawn or made unusable upon a withdrawal or taking of leased land that causes any portion of the land to become unusable for the specific use or uses for which it was leased. Prohibits any land that is under cultivation to be withdrawn or taken until the crops are harvested, unless the board of land and natural resources pays the lessee the value of the crops. Requires the board to pay to the lessee the difference between the appraised breeding value and the salvage value, including the cost of transportation to a market on the island on which the leased land is located if the breeding livestock cannot be relocated or marketed for the breeding value. -- HB1617 CD1

### HB 1671 HD2 SD2 RELATING TO PROCUREMENT

Vetoed (07/10/12)

Amends provisions relating to the Hawai'i public procurement code. Establishes provisions requiring the state procurement office to keep statistics on solicitations and awards protested. -- Amends provisions relating to administrative proceedings for review. Requires the several hearings officers appointed by the director of the department of commerce and consumer affairs to have jurisdiction to review and determine any request from any bidder, offeror, contractor, person, or governmental body aggrieved by a determination of the chief procurement officer, head of a purchasing agency, or a designee of either officer. Provides that the party shall have the burden of proof, including the burden of producing evidence as well as the burden of persuasion. -- Requires party initiating proceedings to pay the department of commerce and consumer affairs a specified cash or protest bond amount that will be returned if the initiating party prevails. -- Reduces the number of days the hearings officer has to transmit the record of the administrative proceedings to the circuit court upon the filing of an application for judicial review. Provides that judicial review shall be resolved within 30 days or the circuit court shall lose jurisdiction and the decision of the hearings officer shall remain. -- HB1671 SD2

Amends Act 253, session laws of 2007, establishing the energy systems development special fund to develop an integrated approach and portfolio management of renewable energy project that will reduce Hawai'i's dependence on fossil fuel and imported oil and other imported energy resources and move Hawai'i toward energy self sufficiency by extending the sunset date. -- HB1726 CD1

Establishes provisions relating to computer fraud in the 3rd degree. Provides that a person commits the offense of computer fraud in the 3rd degree if the person knowingly accesses a computer, computer system, or computer network with the intent to commit the offense of theft in the 3rd or 4th degree. Makes it a class C felony. – Amends provisions relating to computer fraud in the 1st degree. Provides that a person commits the offense of computer fraud in the 1st degree if the person knowingly accesses a computer, computer system, or computer network with the intent to commit the offense of theft in the 1st degree. Makes it a class A felony. -- Provides that a person commits the offense of computer fraud in the 2nd degree if the person knowingly accesses a computer, computer system, or computer with the intent to commit the offense of theft in the 2nd degree. Makes it a class B felony. -- Amends provisions that a person commits the offense of unauthorized computer access in the 1st degree if the person knowingly accesses a computer, computer system or computer network without authorization and thereby obtains information, and the offense was committed for the purpose of commercial or private financial gain, the offense was committed in furtherance of any other crime, the value of the information obtained exceeds 20,000 dollars, or the information has been determined by a statute or to require protection against unauthorized disclosure. Makes it a class A felony. -- Amends provisions relating to unauthorized computer access in the 2nd degree. Provides that a person commits the offense of unauthorized computer access in the 2nd degree if the person knowingly accesses a computer, computer system, or computer network without authorization and thereby obtains information. Makes it a class B felony. -- Amends provisions relating to unauthorized computer access in the 3rd degree. Provides that a person commits the offense of unauthorized computer access in the 3rd degree if the person knowingly accesses a computer, computer system, or computer network without authorization. Makes it a class C felony. -- HB1788 CD1

Prohibits physicians, osteopathic physicians, surgeons, or students participating in a course of instruction, residency program, or clinical training program from performing a pelvic examination on an anesthetized or unconscious female patient unless the patient gives prior verbal or written informed consent to the pelvic examination, the performance of a pelvic examination is within the scope of care for the surgical procedure or diagnostic examination scheduled to be performed on the patient, or the patient is unconscious and the pelvic examination is required for diagnostic purposes. -- HB2232 CD1

# HB 2242 HD1 SD1 RELATING TO CONTINUING EDUCATION FOR VETERINARIANS

Act 306 (07/09/12)

Amends provisions relating to definitions under veterinary medicine law. Adds definitions for continuing education courses and for credit hour. Amends provisions relating to licenses. Makes failure to renew on or before June 30 of each even numbered year an automatic forfeiture of license and provides for restoration schemata. Prior to payment deadlines for license renewal requires licensees to pay all required fees and to complete at least 20 credit hours of continuing education within the 2 year period preceding the renewal date. Exempts licensees who have graduated within 1 year of the 1st license renewal from continuing education requirement for the 1st renewal. Requires licensees to certify compliance with continuing education requirements under oath and allows the board of veterinary examiners to require licensees to submit satisfactory evidence of compliance with the requirement. Allows the board to conduct random audits to determine compliance with continuing education requirements. Amends provisions relating to refusal to grant and revocation or suspension of license by including among the false statements for which a license may be revoked or suspended, a false certification of compliance with continuing education requirements. -- HB2242 SD1

# HB 2265 HD2 SD2 CD1 RELATING TO THE STATE PROCUREMENT CODE Act 173 (06/27/12)

Amends provisions relating to the Hawai'i public procurement code. Establishes provisions requiring the state procurement office to keep statistics on solicitations and awards protested. Provides that procurements of greater than 50,000 dollars also requires a payment bond. Provides that small purchase procedures shall be used for procurements of 25,000 dollars to 250,000 dollars. -- Amends provisions relating to administrative proceedings for review. Requires the hearings officers to issue a decision within 45 days. Requires party initiating proceedings to pay the department of commerce and consumer affairs a specified cash or protest bond amount that will be returned if the initiating party prevails. -- Reduces the number of days the hearings officer has to transmit the record of the administrative proceedings to the circuit court upon the filing of an application for judicial review. Provides that judicial

review shall be resolved within 30 days or the circuit court shall lose jurisdiction and the decision of the hearings officer shall remain. -- Amends Act 175, session laws of 2009, as amended by Act 107, session laws of 2010, by repealing the sunset provisions changing small purchases to less than 100,000 dollars for goods or services and 250,000 dollars for construction. Requires security by performance and payment bonds delivered to the procurement officer for procurements greater than 50,000 dollars for construction and requires that procurements of 25,000 dollars to less than 250,000 dollars be made in accordance with small purchase procedures; provided that small purchase procurements through an electronic system shall be required. -- HB2265 CD1

### HB 2012 HD1 SD1 CD1 (Act 106, SLH 2012)

RELATING TO THE STATE BUDGET

SECTION 4. Part III, Act 164, Session Laws of Hawaii 2011, is amended:

(14) By adding a new section to read as follows:

"SECTION 23.3. Provided that the John A. Burns School of Medicine (UOH 110) shall prepare an annual comprehensive report detailing all expenditures of the school; provided further that the report shall be submitted to the legislature no later than September 1 of 2012."

SECTION 15. Part VII, Act 164, Session Laws of Hawaii 2011, is amended:

(11) By adding a new section to read as follows:

SECTION 132.1. Provided that the University of Hawaii shall prepare a plan to prevent growth in the university's repair and maintenance backlog, systemwide, through the use of its special fund revenues; provided further that the plan shall include but is not limited to the following:

- (1) The estimated value of the university's repair and maintenance backlog, categorized by campus and types of projects;
- (2) Amounts that must be expended each year to prevent the repair and maintenance backlog from growing, categorized by campus and types of projects;
- (3) Planned expenditures, by campus, types of projects, and funding sources; and
- (4) An update on current staffing authorized to implement the university's capital renewal, including status of positions;

provided further that the plan shall cover the six-year planning period following fiscal year 2012-2013; provided further that the plan shall not rely on the use of general funds or general obligation bond funds to fund repair and maintenance projects after fiscal year 2012-2013; provided further that the University of Hawaii shall submit the plan to the legislature no later than thirty days prior to the convening of the 2013 regular session."

(12) By adding a new section to read as follows:

"SECTION 132.2. Provided that the University of Hawaii shall prepare a report on all of its revenue sources that includes the following:

- (1) A description of each source of revenue to include identification of the source and amounts;
- (2) The actual and projected uses for each source of revenue identified by specific categories for expenditure and amounts; and
- (3) Identification of all obligations, projected obligations, and amounts placed on each source of revenue in excess of those identified in paragraph(2), including but not limited to revenues and reserves required to issue and pay the debt service on bonds, fund other debt instruments, fund projected collective bargaining increases, and initiate or expand programs;

provided further that the report shall cover actual and projected data for fiscal year 2012-2013 and projections for the subsequent six-year planning period; provided further that the University of Hawaii shall submit the report to the legislature no later than thirty days prior to the convening of the 2013 regular session."
