4. Transition plan, timeline, next steps

Because there were no further modifications to the 3/28/07 version of the articulation agreement, the group decided to move ahead with a timeline for implementation. The implementation process will likely have campuses doing several things at the same time and campuses will "come on board" at different times. Below is a recommended timeline. We recognize this is the ideal. The deadlines are only suggested and very flexible.

Overview. This is a three-step process: (1) Multicampus HAP group approves articulation agreement. (2) Campuses approve the articulation agreement. (3) Campuses apply to have their HAP Program approved by a system HAP Board.

Multicampus HAP group approves the 3/28/07 articulation agreement (or approves a modified version)	May 2, 2007	When everyone's okay with articulation agreement, we'll move forward. Some campuses want their Faculty Senate (FacSen) to vote on it this semester. (e.g., the last FacSen meeting at HonCC is May 10) What do you think? Is the 3/28 version okay to move forward with? This needs a vote.
Each campus creates a HAP Board and designates a person to serve as chair and system representative.	Before asking FacSen to approve agreement	Each campus can form its HAP Board while preparing to take the agreement to the FacSen and Chief Academic Officer (CAO).

Designate classes on your campus as HAP	As early as Fall 2007 for the Spr08 semester	A campus's HAP Board may review proposals to designate its classes as HAP while the campus is getting FacSen and CAO approval and submitting its application to the system HAP Board.
		IMPORTANT: Articulation of the classes may not occur until <u>after</u> the system HAP Board approves the application.
Facilitate student transfer of HAP classes		After receiving approval from FacSen, CAO, and HAP system board, the campus includes the correct information in Banner (student registration system) for each approved HAP sections so students can transfer their HAP to other campuses.
