ACTION REQUESTED:

The Deans of Arts and Sciences request approval of the elimination of the Breadth/Depth requirement of the Colleges of Arts and Sciences and the elimination of the Arts-and-Sciences-specific symbolic reasoning requirement.

RECOMMENDED EFFECTIVE DATE:

Fall semester ~~2013 -2014~~ **FALL 2013**

BACKGROUND:

Presently, Arts and Sciences (A&S) students must fulfill a "Breadth/Depth" requirement. They have the option of either taking three credits from each of the four A&S colleges ("Option 1-Breadth"); or completing a minor, a certificate, or a second major in A&S ("Option 2-Depth").

The BFA, BMus, BS, and BA-IS degrees are exempt from "Breadth/Depth." Technically, this exemption is via an "Option 3" in the case of BFA, BMus, and BS; and a separate stipulation in the case of B-IS.

In addition to Breadth/Depth, Arts and Sciences students must fulfill the "Arts-and-Sciences-specific symbolic reasoning requirement," by taking at least one course from those that fulfill the Manoa Symbolic Reasoning Foundation requirement (FS). The practical effect of the present A&S-specific symbolic reasoning requirement is this: Although an AA degree from a community college is otherwise accepted as fulfilling the lower division general education core, Manoa A&S students must still fulfill the Manoa FS requirement, even though they hold the AA degree.

The A&S BS degree has additional math/science requirements. These BS requirements are not at issue; no one has proposed their elimination.

The A&S Faculty Senate Executive Committee invited all members of the A&S Faculty Senate to a town hall meeting on March 22, 2013, to discuss whether changes to the current A&S requirements are needed. Faculty who were not able to attend the meeting were able to contribute to the discussion by leaving comments electronically via Survey Monkey. Feedback from both the town hall meeting and the survey was overwhelmingly in favor of eliminating both the A&S Breadth/Depth and Symbolic Reasoning requirements. Following the town hall discussion, Senate members were asked to vote on the question of eliminating these requirements. The proposal to eliminate the requirements was supported by a substantial majority of those voting.

The Arts and Sciences Faculty Senate Executive Committee then recommended to the Deans of Arts and Sciences that these requirements be eliminated. A copy of the memorandum from the SEC to the Council of Deans is attached. It explains in greater detail the consultation process and the rationale for the recommendation.


The Deans of Arts and Sciences concur with the recommendation of the Faculty Senate.
