New Business

- C3T Grant Reporting Requirements Lynn Inoshita reviewed Round One and Round Two of the C3T grants and stated that she is the Data Lead for Round One. C3T, Round One is a three-year grant from the Department of Labor for the consortium of the seven UHCC colleges focusing on Agriculture, Energy and Health Care. The grant requires tracking cohorts of credit and non-credit students who receive skill training/development services. Lynn will compile the data for the regular reports for the system and for all colleges. Discussions are underway with IRAO to establish C3T tables in ODS. Lynn distributed a C3T Student Coaching (Inside Track) Implementation Plan (as of 10/31/12) and an UHCC-Cohort Tracking Proposal. At a later date she will send copies to the IR Cadre or direct them to the C3T site that houses the forms and other information. A question was raised about additional reports that colleges might want - Lynn Inoshita stated those will be the responsibility of the individual college. Kristine Korey-Smith recounted her experience with InsideTrack student coaching.
- ☐ UH System ITS Information Security Awareness IR Cadre who are Banner Users received an email from Banner Central regarding access to Sensitive Information requirements which will go into effect January 28, 2013. APAPA will follow up with IRAO to see if similar procedures will be in place for ODS users.
- □ PacAIR Review Overall, IR Cadre who attended PacAIR appreciated the opportunity to meet with others doing similar work and thought VP Johnsrud's presentation on
