The statement of purpose is a very important portion of your application. This statement should not exceed 5 double-spaced typewritten pages, using a font no smaller than 12 points. Please be as specific as possible in answering the questions below:

- Discuss your qualifications and readiness for pursuing doctoral studies in social welfare.
- Describe your view of the role of research in social welfare.
- Describe the area of specialization around which you wish to concentrate your study and research. In specifying your area of research interest, please identify social welfare Ph.D. faculty who might be useful to you in exploring your area. Indicate any special projects of research emphasis at the School of Social Work or within the larger University that you view as helpful resources.
- Describe the development of your interest in research and the relation of that interest to your professional area of specialization.

- Illustrate how your personal history, family background, and intellectual development have influenced your decision to pursue social welfare research as a career goal. As appropriate, note cultural and educational opportunities that you have experienced and any educational, social, or economic disadvantages that you have had to overcome.
- What are your career plans? Specifically, how do you expect to use the research and scholarly skills developed in the doctoral program?

The statement of purpose should help reviewers understand how your career goals are relevant to the professional and intellectual commitments of social work. Do this by showing how your research interests connect to the research interests of faculty members in social work and other disciplines at the University of Hawai'i.
