

What is a Traffic Abstract?

Certified Traffic Abstracts are available at most district courthouses throughout the state. The abstracts show a history of all moving citations issued in Hawai'i, including those which were later dismissed. This is pursuant to Hawai'i Revised Statutes Section 287-3. There are two types of traffic abstracts: regular traffic abstract and complete abstract (also called 'court abstract').

If you intend to transport your mentee, you must get a complete/court abstract and provide it to STRIDE staff for your file. You will need to have an abstract without violations to transport the mentee.

How can I get a copy of an abstract?

You can get a complete abstract (a court abstract), which shows all violations that the court has in its computer system, at any courthouse. This abstract will only be provided to the individual for whom the abstract is requested; **a photo I.D. is required.** Also, **please provide the individual's full name. The date of birth and driver's license number may also be submitted to ensure that the requested record is provided.** If only the name is provided and the search results in more than one record with the same name, the requestor may have to purchase all records with the same name. Each abstract is a certified record given by the court and costs **\$7.00 per abstract.** Personal checks will not be accepted.

Which violations appear on an abstract?

All alleged moving violations as well as any convictions will appear on the abstract. Violations on the abstracts are shown pursuant to order of the Supreme Court retention schedule:

- **Driving-Under-the-Influence (DUI) Violations.**
- **Moving Violations**
- **No Fault Violations**
