Approval of Minutes

CLEAR Director's Report - Dr. William Puette

- Rutledge Endowment
 - The market value of the endowment as of September 30, 2022, is \$1,343,914.63
- Labor Studies Certificate

Dr. Lopez gave a brief update of the certificate. This semester, we are offering Labor Studies 100, 200, 300 and 400 courses. CLEAR has received collections of arbitration's from the Industrial Relations Center that can be used for courses on arbitration's.

- Book Talk, February 4and 6, 2023 with Joe Burns
 - Dr. Lopez shared with the council the presentation by Joe Burns and Eric Gill. There were approximate 60 in attendance for both days.
- Labor Spring Teach in, April 2023
 - Dr. Lopez is planning the "Teach in" on April 12, 2023 at noon. This is part of a national initiative for labor education in higher education.
- CLEAR's Labor Economist Position update

Dr. Jeffrey Moniz, VCAA and David McDonald, VCA, both shared with the council the update of this position. There is a moratorium for Specialist positions at UH Hilo and UH West Oahu. This position has been re-described from a Specialist to an Assistant Professor, 9-month and waiting for the Chancellor

to sign off on the re-description. It is currently sitting on her desk for her approval. Once approved, the next step is President Lassner's approval. The final step will be the Board of Regents. The following people have agreed to serve on a *adhoc* committee: Clyde Hayashi, Morris Luka, Janet Suster, Cathy Lederer, and Dion Dijon.

• CLEAR Temporary Office Relocation during Library Renovation
The entire Library building will be closed from March 13, 2023 for at least 6 months for air conditioning renovation. There will be no access to CLEAR's archive or law library as well as visiting. All our offices will be temporarily relocated to just one office, D231.
