

2019-20 Instructions for Income Information Required on the Verification Worksheet

If you have been selected for verification, you must verify the income you reported on your financial aid application (FAFSA). The following are ways to verify your income information:

IRS Data Retrieval

The best way to verify income is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web. This feature can be used only if you filed a 2017 Federal Income Tax Return.

If you filed an amended 2017 tax return (Form 1040X), you must also provide a copy of the signed amended tax return **AND** an IRS Tax Return Transcript for 2017; if you did not use the IRS Data Retrieval Tool, to the financial aid office.

Request an IRS Tax Return Transcript

You will need your Social Security Number (SSN), date of birth, email, tax filing status and the address on file with the IRS (this will be the address used when your 2017 IRS tax return was filed). Please be sure to write the student's ID Number or UH Username and student's first and last names on the transcript before submitting it to the Financial Aid Office. NOTE: the IRS Transcript will be mailed to the address that was listed when filing the tax return. If your address has changed, you must complete IRS Form 8822 Change of Address, wait 4-6 weeks then submit a request.

To obtain an IRS tax return transcript:

Confirmation of Non-Filing Status

ALL tax non-filers, except students who had to provide parent information on the FAFSA, must provide confirmation of non-filing if a tax return was not filed and was not required to be filed. A confirmation of non-filing can be obtained from:
