### Access to Justice: A Promise We Can Keep

The session will also discuss issues of recruitment, including whether experienced attorneys should be recruited to train and mentor pro bono attorneys who request cases in areas in which they have not traditionally practiced or are YLD members; what draws attorneys to volunteer; what pulls them away; explore strategies for addressing the challenges.
