Reaffirming ASUH's position against UH's status as a University Affiliated Research Center (U.A.R.C)

My name is Bronson Azama, I am the current President elect of the Associated Students of the University of Hawai'i (ASUH) at Mānoa..

#### **A RESOLUTION**

# DEMANDING THE UNIVERSITY OF HAWAI'I NO LONGER SERVE AS A UNIVERSITY AFFILIATED RESEARCH CENTER

#### BE IT ENACTED BY THE UNDERGRADUATE SENATE:

WHEREAS, the Associated Students of the University of Hawai'i (ASUH) at

Mānoa Senate is the elected body representing approximately 12,000

full-time classified undergraduate students; and,

WHEREAS, during the late 1960s the University of Hawai'i via contract with the

army conducted weapons testing of Agent Orange on the island of Kaua'i which some researchers developed significant health

impacts1; and

WHEREAS, In 1961 President Eisenhower in his farewell address warned, "In the

councils of government, we must guard against the acquisition of unwarranted influence, whether sought or unsought, by the military industrial complex. The potential for the disastrous rise of misplaced power exists and will persist...the free university, historically the fountainhead of free ideas and scientific discovery, has experienced a revolution in the conduct of research. Partly because of the huge costs involved, a government contract becomes virtually a substitute for intellectual curiosity...The prospect of domination of the nation's scholars by Federal employment, project allocations, and the power of money is ever present and is gravely to be regarded. Yet in holding scientific research and discovery in respect, as we should, we must also be alert to the equal and opposite danger that public policy could itself become the captive of a scientific technological elite"<sup>2</sup>; and

WHEREAS, In 1967 Rev. Dr. Martin Luther King Jr at the National Conference on New Politics referenced militarism as one of the three evils of an

|          | afflicted society, and further states, "when scientific power outruns moral power, we end up with guided missiles and misguided men." <sup>3</sup> ; and  |

| WHEREAS, | from the late 1990s to early 2000s University of Hawai'i (UH) faculty were concerned on the implication classified research would have on academic freedom <sup>4</sup> ; and,  |
| WHEREAS, | in 2005, ASUH passed Senate Resolution 11-05, which urged the University of Hawai'i to abandon establishing a University Affiliated Research Center (U.A.R.C); and,   |
| WHEREAS, | prior to the proposal of UH as a U.A.R.C UH officials including personnel of the Research Corporation of the University of Hawai'i (RCUH) were implicated in a Navy Criminal Investigation for contract fraud; <sup>5</sup> and,                        |
| WHEREAS, | these individuals were proponents of the U.A.R.C; and   |
| WHEREAS, | in April 2005, students and faculty conducted a seven-day sit-in at Bachman Hall in opposition to military research at the University and to the establishment of a U.A.R.C <sup>6</sup> ; and  |
| WHEREAS, | on November 16, 2005, the Mānoa Faculty Senate passed a resolution calling for the University to not establish a U.A.R.C <sup>7</sup> ; and   |
| WHEREAS, | On November 21, 2005, on an episode of <i>Island Insights</i> , the Vice-Chancellor Gary Ostrander refuted claims saying, "it's not set-up to do weapons we do not see this as military research in the sense of developing weapons" <sup>8</sup> ; and |
| WHEREAS, | Vice-Chancellor Ostrander, further concluded that the telescopes on   |

| WHEREAS, | on December 5, 2005, Chancellor Konan of the University of Hawai'i at Mānoa rejects U.A.R.C at Mānoa; and  |

| WHEREAS, | On January 20, 2006, a majority of students and faculty opposed U.A.R.C, as well as a petition submitted in opposition of about 170 signatures in opposition from William S. Richardson School of Law <sup>10</sup> ; and  |
| WHEREAS, | In March 2006, over 200 students and community members gathered outside of Bachman Hall to oppose U.A.R.C and military research <sup>11</sup> ; and  |
| WHEREAS, | On September 26, 2007, students and faculty attempted to submit a report, <i>The Dirty Secret About UARC</i> <sup>12</sup> but were locked out of Bachman Hall <sup>13</sup> this report was received by University Public Affairs official <sup>14</sup> ; and  |
| WHEREAS, | in the reports by Save UH/Stop UARC Coalition, the U.A.R.C's origins are tied to individuals as mentioned above RCUH and UH officials who were under investigation by the Naval Criminal Investigative Services N.C.I.S for contract fraud <sup>15</sup> ; and   |
| WHEREAS, | on September 27, 2007, despite opposition from students and faculty, and testifiers expressing concern on "classified" research, task orders, and academic freedom, the UH Board of Regents approved the establishment of the Applied Research Laboratory (ARL) as an administrative unit in the UH System <sup>16</sup> ; and |
| WHEREAS, | The University of Hawai'i therefore became the first Naval U.A.R.C to be established since President Franklin D. Roosevelt <sup>17</sup> ; and   |

| WHEREAS, | on July 16, 2013, President Greenwood approved the extension of the U.S Navy contract with ARL <sup>18</sup> without public input; and  |

| WHEREAS, | on May 24, 2018, the BoR Committee on Research and Innovation was provided meeting material that stated the next contract would include a security level of "top secret" and  |
| WHEREAS, | on October 3, 2018, rather than question the militarization of the University and the research being conducted, members of the BoR instead questioned the optimization of resources <sup>20</sup> ; and             |
| WHEREAS, | on December 28, 2018, Honolulu Civil Beat reported that ARL was preparing to renew a contract that would include "top secret" research and that 30% of Classified research was on Cybersecurity <sup>21</sup> ; and |
| WHEREAS, | on May 13, 2019, ARL was awarded a \$72,209,225 five-year Indefinite Delivery/ Indefinite Quantity contract from Naval Sea System Command (NAVSEA) to receive task-ordered research; and                            |
| WHEREAS, | following the new contract, ARL anticipates a fourfold increase in annual revenue <sup>22</sup> ; and   |
| WHEREAS, | in May 2020, ARL was awarded a \$75,000,000 contract with the Air Force Research Laboratory for the Maui High-Performance Computing Center (MHPCC) to be completed in 2024 <sup>23</sup> 1; and                     |
| WHEREAS, | the 2020 Annual Report of the Applied Research Laboratory (ARL) it revealed that since its inception 96% of the U.A.R.C has been directly funded by military agencies; and  |
| WHEREAS, | President Lassner is a principal investigator on the MHPCC, the largest contract for ARL to date, and other DoD Funded contracts <sup>24</sup> ; and  |

WHEREAS, the ASUH reaffirms its opposition to the establishment of U.A.R.C

and the conduct of classified military research within the UH

System; and

WHEREAS, the ASUH reaffirms its support of Academic Freedom; and now,

therefore

BE IT RESOLVED, the ASUH demands transparency on all research being conducted at

a Public Institution; and

BE IT FURTHER RESOLVED, that ASUH shall fill out the Presidential Search Survey, demanding

that the next UH President works with the Board of Regents to terminate and discontinue the U.A.R.C contract and status of the

University of Hawai'i; and

BE IT FURTHER RESOLVED, that ASUH requests the next President not be allowed to conduct

research projects associated with the Department of Defense (DoD)

and its various agencies; and

BE IT FURTHER RESOLVED, that the Board of Regents reduce the autonomy granted to the UH

President, and provide more oversight and public transparency over

the operations of the UH System; and

BE IT FINALLY RESOLVED, a copy of this resolution be submitted to the UH President David

Lassner, the Board of Regents, the University of Hawai'i Student Caucus, Chair Amy Perruso of the House Higher Education Committee, Chair Donna Mercado Kim of the State Higher

Education Committee, Congressman Ed Case, Congresswoman Jill

Tokuda, Senator Brian Schatz, and Senator Mazie Hirono.
