I am Kekailoa Perry, a citizen of the Hawaiian Kingdom and Associate Professor at Kamakakūokalani Center for Hawaiian Studies. My testimony opposes all BOR action relating to the

- 1. In the past 10 months the UH BOR and Administration have done significant damage to our Hawaiian community by silencing our voices, downplaying our cultural concerns and allowing racist attacks to enjoy structural protections in the name of free speech (see my previous emails, letters and testimonies). The UH BOR and administration's draft strategic plan pretentiously appropriates kanaka 'oiwi (native Hawaiian) political, cultural and linguistic identity by claiming that the UH will be an Aloha 'Āina university. Your proposed plan is abusive and traumatizing to our communities. The UH BOR and administration's actions here are hypocritical and do not -- even remotely -- reflect Aloha 'Āina.
- 2. Your insistence on possessing the traditional Hawaiian practice of Aloha 'Āina is appalling. Your past (and present) actions on matters concerning Hawaiian lands and culture shamefully contradict the function and purpose of Aloha 'Āina. To demonstrate a more clear commitment to Aloha 'Āina, the UH BOR and administration must take these first steps and actions:
 - (1) End and reverse all actions relating to agenda items V.C. through V.D.
 - (2) End all policies that support the building of TMT on Maunakea.
 - (3) Create a policy that ends all future development and reverses current developments on sacred Hawaiian lands.
- 3. Holding decision making meetings on the TMT and other critical matters that will impact the Hawaiian community at this time is equivalent to weaponizing the stay at home orders and health fears of our community in ways that will limit our full participation in the BOR processes. That is not Aloha 'Āiṇa.
- 4. Aloha 'Āina is not one of those cultural items on the buffet line where the UH BOR and administration can pick the meanings that suit their tastes. Aloha 'Āina does not belong to the UH. The BOR and administration's attempt to claim Aloha 'Āina is perverse. To wit: your actions in support of the TMT shows a deceitful approach that will further the abuse of our culture, society, lands, natural resources and people. Please stop your lies. Maunakea and Aloha 'Āina are not the properties of UH and are not for sale.
