Dear Regents,

I am writing as a member of the UH faculty to share my concerns about the persistent and increasing confusion regarding the future of academic programs at UH Manoa. These are "unprecedented times" indeed, but much of the damage is only caused indirectly by the COVID-19 pandemic; the immediate cause of our predicament are political and administrative decisions - or the lack thereof.

We, the faculty, are willing and ready to help, but open and honest communication is central to this process. As departments and schools are reviewing their options and priorities, mixed and conflicting messages from the Manoa administration cause anxiety and confusion. Programs previously slated for elimination are now declared safe, sometimes within a newly organized school or reorganized department. The Office of the Provost even promises some programs additional resources or faculty - during a massive budget crisis.

Straight talk, honesty, and a critical review of UH's past and current decisions will be needed to mitigate the damage done; we, the faculty, stand by to participate constructively in this process.
