

INTRODUCTION

On Thursday, May 4, 2006, the 23rd Legislature of the State of Hawai'i came to a close. This report summarizes state legislation of interest to the University of Hawai'i.

This session, the University of Hawai'i had a total of nine bills that were introduced by the Governor as part of her administrative package. Two of these proposals passed:

- House Bill 1866 allows the University of Hawai'i and the Department of Education to exercise sole responsibility over its accounts without supervision by the State Comptroller until the year 2011; and
- House Bill 3194 amends statutory provisions of the Commission for National and Community Service to conform to federal standards.

Other proposals passed by the 2006 State Legislature affecting the University include:

- Senate Bill 2961 allows for an increase in the cigarette tax with funds from the increase going to the Cancer Research Center of Hawai'i;
- House Bill 2275 allows emergency authorization to cover increased electricity costs on all campuses;
- Senate Bill 3120 establishes the Hawai'i state scholars financial assistance program, a
 workforce development scholarship program for community college students, and
 provides for an increase in the amount of funding for the B Plus scholarship program;
- Senate Bill 2980 establishes a construction academy within the community college system to meet critical shortfalls in construction labor.

From a financial perspective, the University's Supplemental Operating Budget Request for FY 2006-07 (general funds) as approved by the BOR totaled \$41.5 million. Of this amount, the Governor approved a total of \$23.7 million. The Executive Supplemental Operating Budget Request that was submitted to the 2006 Legislature included this amount and an additional \$21.2 million (not including pass-through adjustments) for various higher education initiatives proposed by the Governor for a grand total of \$44.9 million.

The Legislature subsequently approved a total increase of \$29 million to the University's operating budget for FY 2006-07. \$17.4 million of this amount is attributable to items in the BOR Budget, \$6.3 million to the Governor's initiatives, and \$5.3 million for Legislative initiatives.

While it may appear that the Legislature only approved \$29 million of the \$44.9 million request, it should be noted that a \$10 million operating budget request for repair and maintenance projects (Governor's initiative) was transferred to the CIP portion of the budget and increased to \$30 million. In addition, the means of financing for this item remained as general funds. Therefore, total general funds appropriated for the University is actually \$59,019,530. This amount represents approximately 10% of the estimated \$600 million state surplus that was appropriated by the Legislature for FY 2006-07.

In capitol improvement funding, the Hawai'i State Legislature approved more than \$95 million for the University's Capital Improvements Program budget for the 2006-2007 fiscal year. The amount included \$42.5 million in general funds and \$24.2 million in general obligation bond funds, as well as the authorization to expend more than \$28 million in federal, private and revolving funds.

Of the total, \$30 million was appropriated for repairs and maintenance and nearly \$7.5 million to address health, safety and code requirements for projects at the University. Other major projects funded include:

- \$5 million in additional construction funds for the Science and Technology Building at UH Hilo
- Nearly \$2.6 million for design of the Library and Learning Resources Center at Windward Community College
- More than \$1.3 million for the design of a new classroom building and renovations to Gartley Hall on the Mānoa campus
- \$1 million for the design of an Information Technology Center for the University system
- \$2 million for equipment at the Institute for Astronomy's Advanced Technology Research Center in Kula, Maui

HB 1 HD2 SD1 RELATING TO HIGHER EDUCATION

Act 75 (5/2/06)

Establishes the University of Hawai'i System law. Repeals the Hawai'i Research Center for Futures Study law, University of Hawai'i law, Center for Nursing law, Community Colleges law, Career and Technical Education Under Federal Aid law, College Credit Equivalency Program law, State Post Secondary Education Commission law, University Projects law, Research Corporation of the University of Hawai'i law, University parking law, and Western Regional Education Compact law.

HB 266 HD1 SD2 CD1 RELATING TO LABOR

Vetoed (7/11/06)

Amends provisions relating to scope of negotiations; consultation. Prohibits this provision to be used to invalidate provisions of collective bargaining agreements in effect on and after June 30, 2007, and to preclude negotiations over the procedures and criteria on promotions, transfers, assignments, demotions, layoffs, suspensions, terminations, discharges, or other disciplinary actions as a permissive subject of bargaining during collective bargaining negotiations or negotiations over a memorandum of agreement, memorandum of understanding, or other supplemental agreement.

HB 1280 HD1 SD2 CD1 RELATING TO FLOOD CONTROL

Act 187 (6/13/06)

Requires the Center for Conservation Research and Training (CCRT) of the University of Hawai'i to develop comprehensive watershed management plans to develop the best strategies to manage flooding caused by storm runoff in at least 2 of Hawai'i 's most severely flood impacted watersheds as identified by the center and to coordinate the implementation of those best watershed management measures developed. Appropriation. (\$\$)

HB 1866 HD1 SD2 CD1 RELATING TO EDUCATION

Act 161 (6/1/06)

Amends provisions relating to comptroller to supervise accounts. Provides that the comptroller shall not have supervision of all accounts of the University of Hawai'i until June 30, 2011. -- Amends Act 321, Session Laws of 1986, as amended by Act 283, Session Laws of 1987, Act 371, Session Laws of 1989,

Act 163, Session Laws of 1991, Act 314, Session Laws of 1993, Act 8, Special Session Laws of 1993, Act 180, Session Laws of 1997, Act 115, Session Laws of 1998, and Act 137, Session Laws of 2005, which excludes the accounts of the University of Hawai'i and the Department of Education from being supervised by the comptroller of the Department of Accounting and General Services, by repealing the sunset date of June 30, 2006.

HB 1889 HD1 SD2 CD1 RELATING TO THE OFFICE OF INTERNATIONAL

AFFAIRS

Act 172 (6/5/06)

Establishes the Office of International Affairs within the Department of Business, Economic Development, and Tourism, an Office of International Affairs. Requires the office to develop policies that promote and strengthen international business, economic, culture, and arts relations with other countries; develop policies that promote transportation and tourism within other countries; develop and promote international telecommunications and high technology exchanges; encourage the development of international sister city programs; develop and promote Hawai'i as the economic, trade, commerce, transportation, banking and tourism hub of the Pacific; develop an international affairs and peace education curriculum; and provide for exchanges between Hawai'i and other nations of individuals who endeavor to develop international and peace based initiatives.

Act 160 (6/1/06)

Supplemental Appropriations Act of 2006 (executive budget). Amends Act 178, session laws of 2005, relating to the state budget.

HB 2045 HD2 SD1 CD1 RELATING TO PERINATAL CARE

Act 248 (6/29/06)

Establishes within the John A. Burns School of Medicine university clinical educational and research associates program at the University of Hawai'i Department of Obstetrics, Gynecology, and Women's Health, a pilot Perinatal Clinic, which in collaboration with the Departments of Pediatrics and Psychiatry will provide prenatal, delivery, and postpartum care for women with a history of substance use on the island of Oahu; substance use counseling; pediatric care with appropriate developmental interventions; psychiatric care for patients with dual diagnoses; and case management, including social services and coordination with child welfare services to ensure that the home environment is safe and to prevent the

abandonment of children, and keep families intact whenever possible, as long as the safety of the children can be assured. Requires funding to be pursued through the state Medicaid program. Requires the pilot perinatal clinic to cease operations on June 30, 2009 (sunset). Appropriation. (\$\$)

HB 2145 HD2 SD1 CD1 RELATING TO AGRICULTURAL TOURISM

Act 250 (6/29/06)

Amends provisions relating to districting and classification of lands. Provides that agricultural districts include agricultural tourism conducted on a working farm or farming operation, for the enjoyment, education, or involvement of visitors; provided that the agricultural tourism activity is accessory and secondary to the principal agricultural use and does not interfere with farm operations. Requires the counties to adopt ordinances for the review and permitting of agricultural tourism uses and activities.

HB 2146 HD1 SD1 CD1 RELATING TO LAND USE

Act 271 (7/4/06)

Amends provisions relating to permissible uses within the agricultural districts. Provides that agricultural lands may be subdivided and leased for the agricultural uses or activities permitted provided that the principal use of the leases land is agriculture; no permanent or temporary dwellings or farm dwelling, including trailers and campers, are constructed on the leased area; and the lease term for a subdivided lot shall be for as long as the longer of the minimum real property tax agricultural dedication period or 5 years. Further provides that lots created and leased are considered legal lots of record for mortgage lending purposes and are exempt from county subdivision standards. -- Amends provisions relating to exemptions from the uniform land sales practices act. Exempts offers or dispositions of an interest in land where the land is a leasehold agricultural lot located within State agricultural districts on which no dwelling structures are constructed.

HB 2175 HD2 SD2 CD1 RELATING TO ENERGY

Act 96 (5/12/06)

Appropriation to the Department of Education to develop and implement a photovoltaic, net energy metered pilot project at 1 public school within each of the counties of Oahu, Hawai'i, and Kauai and 1 in the Maui county. Reports to the legislature. -- Amends the energy resources law by establishing provisions relating to energy efficiency and environmental standards for state facilities, motor vehicles,

and transportation fuel. -- Amends the energy resources law. Changes the membership of the advisory committee to include the University of Hawai'i and to delete county government. Requires the committee to provide input on how to establish benchmarks and evaluate the State's progress in energy efficiency and conservation; make recommendations on how and when to conduct periodic energy audits; and make annual reports to the legislature. Provides that energy saving contracts shall include energy performance contracts; municipal lease and purchase financing; and utility energy efficiency service contracts. Appropriation to the Department of Business, Economic Development, and Tourism for energy efficiency for state facilities and equipment. -- Requires the Department of Education and the Department of Accounting and General Services to identify projects that need to be funded. Report to the legislature. --Appropriation to the Department of Education for 1 full time energy efficiency coordinator position. --Appropriation to the Department of Business, Economic Development, and Tourism for 2 full time energy coordinator positions to address energy efficiency in the department. – Amends provisions relating to highly energy efficient vehicles by changing it to energy efficient vehicles. Move the procurement percentage of energy efficient vehicles for agencies purchasing or leasing vehicles up to begin in the fiscal year beginning July 1, 2006, and sets new percentages to begin July 1, 2007, and subsequent years. Requires that for each subsequent fiscal year, the percentage of energy efficient vehicles newly purchased shall be 5 per cent more than the previous year until at least 75 per cent of each covered fleet's newly purchased, light duty vehicles are energy efficient vehicles. Provides that agencies may offset the purchase requirements by successfully demonstrating percentage improvements in overall light duty vehicle mileage economy, using biodiesel fuel, and acquiring vehicles from other state agencies. – Establishes provisions relating to county building permits; incorporation of leadership in energy and environmental design building standards in project design; priority processing. (\$\$)

RELATING TO THE STATE BUDGET Section 4

(59) By amending section 61 to read as follows:

"SECTION 61. Provided that of the general fund appropriation for <u>University of Hawai'i</u>, systemwide support (UOH 900), the sum of \$73,800,011 for fiscal year 2005-2006 and the sum of [\$83,010,455] \$80,303,145 for fiscal year 2006-2007 shall be used to pay for debt service on general obligation bonds issued for [university] <u>University</u> of Hawai'i projects and transferred to the financial administration program (BUF 115) of the department of budget and finance for that purpose; provided further that the funds shall be transferred no later than July 16 of each respective fiscal year; provided further that the department of budget and finance shall submit a detailed report comparing general fund appropriations to actual general fund expenditures for the [university] <u>University</u> of Hawai'i's share of general obligation bond debt service for each fiscal year from [the 2001-2002] fiscal year 2001-2002 through the last completed fiscal year, and a projection for each of the succeeding two fiscal years; and provided further that the <u>University shall submit the</u> [this] report shall be submitted to the legislature no later than twenty days prior to the convening of the 2006 and 2007 regular sessions."

RELATING TO THE STATE BUDGET

(21) By adding a new section to read as follows:

SECTION 168.5. Provided that each executive department shall plan for or install energy reduction, energy savings, or energy producing efforts and technologies to lessen electrical consumption or to increase efficiencies in using electrical energy; provided further that each department shall prepare a report on:

- (1) Energy consumption in kilowatt hours for the past two years (July 1, 2004 to June 30, 2006);
- (2) Steps taken to inventory, investigate, plan, and implement energy reduction efforts; and
- (3) A plan or alternatives to reduce energy consumption in the future;

and provided further that each department shall submit the report to the legislature no later than twenty days prior to the convening of the 2007 regular session.
