INTRODUCTION

On Thursday, April 29, 2010, the 25th Legislature of the State of Hawai'i came to a close.

This session, the University of Hawai'i had a total of five bills approved by the Board of Regents (Board), of which four were introduced as part of the Governor's package. Four of the Board approved proposals passed the legislature:

- SB 2389 (became Act 42) repeals the sunset provision in Act 106, Session Laws of Hawai'i 2008, to allow the University of Hawai'i to continue transferring funds, other than general funds and University of Hawai'i Tuition and Fees Special Funds, into the University of Hawai'i Commercial Enterprise Revolving Fund to finance the establishment of new commercial enterprises, with certain exceptions, beyond June 30, 2011.
- SB 2385 (became Act 124) extends to June 30, 2016, University of Hawaii's (UH) authority regarding: (1) Supervision of accounts; (2) Installation of a different accounting system; (3) Business and accounting forms; and (4) Approval of assignments of moneys to creditors. Authorizes the comptroller to request, until June 30, 2016, that UH provide information required for the preparation of income and expenditure statements. Requires UH to report to the comptroller on moneys held outside the state treasury by UH until June 30, 2016.
- HB 347 (became Act 82) provides for a two-year pilot program for UH and the UH Board of Regents regarding certain provisions of the Hawai'i Public Procurement Code. Sunsets on July 1, 2012.
- SB 2386 (became Act 202) establishes the University of Hawai'i capital improvements program project assessment special fund.

The last of these proposals, which failed to pass the legislature, would have allowed the University of Hawai'i Board of Regents to assess fees for campus parking at an open meeting subject to the open meetings law (Chapter 92, Hawai'i Revised Statutes), but exempt from public notice, public hearing, and gubernatorial approval requirements (Chapter 91, Hawai'i Revised Statutes).

Other proposals passed by the 2010 State Legislature affecting the University include:

- HB 2561 (became Act 56) exempts non-ceded lands acquired by the University of Hawai'i after December 31, 1989 from the legislative approval requirements of section 171-64.7, HRS.
- SB 2649 (became Act 46) extends the sunset provision in Act 138, Session Laws of Hawai'i 2005, relating to providing funding to the University of Hawai'i to construct or renovate housing units.
- HB 2542 (became Act 192) addresses the fiscal year 2010-2011 budget shortfall by transferring to the general fund various amounts of excess balances from certain special funds.

In terms of General Fund appropriations, the University's Supplemental Operating Budget Request for FY 2010-11 approved by the Board of Regents (Board) was to maintain the level appropriated by the 2009 legislature with only an additional request for \$2.2 million in funding for the Office of Mauna Kea Management. The executive budget submitted to the legislature by the Governor did not include the \$2.2 million for the Office of Mauna Kea Management and reduced the University's general fund budget by \$54.7 million, basically converting restrictions she had made to the budget in that amount for salary reductions to a reduction in the general fund budget base.

Unfortunately, even as the economy showed signs of stabilizing, General Fund revenues continued to decline and the Council on Revenues' projected a further decrease for the year. The Legislature ultimately appropriated an additional reduction of (\$7.3) million in General Funds for FY 2010-11. The Legislature also transferred (\$4.9) million from the University of Hawaii's Special and Revolving funds to the State General Fund.

On an appropriation base of \$422.7 million for FY 2010-11, this represents more than a (14%) decrease in General Funds from FY 2009-10. The University represents approximately 7.3% of the State's General Fund operating budget.

The 2010 Hawai'i State Legislature appropriated a total of \$178.025 million in State general obligation bonds for University of Hawai'i capital improvements program (CIP) projects for Supplemental Year 2010-2011. This amount includes the reauthorization of \$23.825 million that would otherwise lapse on June 30, 2010.

Highlights of appropriations from the 2010 Legislature include:

- \$18.625 million for Health, Safety, and Code Requirements at various University of Hawai'i campuses;
- \$35.000 million for Capital Renewal and Deferred Maintenance for all University of Hawai'i campuses;
- \$48.000 million for construction of the University of Hawai'i–West O'ahu Campus Development;
- \$20.000 million for plans, design, construction, and equipment for the University of Hawai'i Project Renovate to Innovate; and
- \$28.000 million for construction of the University of Hawai'i at Hilo's College of Hawaiian Language Building.

Requires the office to withhold funds for its operational expenses including salaries of the executive director and staff from the annual charter school general fund appropriation. Requires the office to annually report to the review panel individual and aggregate expenditures of charter schools, distinguishing between operational and instructional purposes. Requires the office to develop a standardized method for charter schools to report the expenditures for operational expenses and instructional purposes and provides that if any charter school fails to report, the office may retain a portion of that charter school's per pupil allocation. Requires the office to calculate a general fund per pupil amount based upon the amount of general funds appropriated by the legislature and released by the governor and the projected enrollment amount used to calculate the general funds appropriated. Annual report to the legislature. Increases the percentage of charter school per pupil allocation given to the charter school by July 20 of each fiscal year. Creates the charter schools account as a separate account into which shall be deposited per pupil distributions.

RELATING TO THE STATE BUDGET

SECTION 4. Part III, Act 162, Session Laws of Hawai'i 2009, is amended:

(14) By amending section 28 to read as follows:

"SECTION 28. Provided that of the special fund appropriation for tobacco settlement (HTH 590), the sum of [\$15,981,387] \$13,581,144 or so much thereof as may be necessary for fiscal year 2009-2010 and the sum of [\$15,981,387] \$13,626,537 or so much thereof as may be necessary for fiscal year 2010-2011 shall be deposited into the university revenue-undertakings fund[-] for the purposes of section 328L-2(b)(4), Hawai'i Revised Statutes; provided further that the University of Hawai'i shall prepare a detailed report on the use of the funds including but not limited to changes in bond principal and interest payments and itemized lists of all other expenditures and uses; and provided further that the University of Hawai'i shall submit the report to the legislature no later than twenty days prior to the convening of the 2011 regular session."

SECTION 6. Part V, Act 162, Session Laws of Hawai'i 2009, is amended:

(6) By adding a new section to read as follows:

"SECTION 70.4. Provided that of the general obligation bond fund appropriation for the University of Hawai'i, systemwide support (UOH 900), the sum of \$62,285,000, or so much thereof as may be necessary for fiscal year 2010-2011, shall be used for capital renewal and deferred maintenance projects; provided that:

- (1) \$520,000 for a new gymnasium to replace Klum gym at the University of Hawai'i at Mānoa
- (2) \$1,700,000 for improvements to the softball stadium, including installation of new field lighting system, roofs over the first and third base bleacher stands, and locker rooms; and
- (3) \$2,000,000 for a four-sided scoreboard and video display system, all auxiliary, shot clock, and locker room clock at Stan Sheriff Center."

SECTION 8. Part VII, Act 162, Session Laws of Hawai'i 2009, is amended by:

(1) By adding a new section to read as follows:

"SECTION 95.1. Provided that in the event that authorized appropriations specified for University of Hawai'i capital improvements program projects listed in this Act or in any other act currently authorized by the legislature are insufficient, and where the source of funding for the project is designated as the general obligation bond fund, the governor may make supplemental allotments from the University of Hawai'i project adjustment fund appropriated in part II and described in part IV of this Act to supplement any currently authorized capital improvements program cost element; and provided further that the governor shall notify the legislature within five days of each use of this proviso and submit a report to the legislature of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the 2011 regular session."

(4) By amending section 134 to read as follows:

"SECTION 134. Provided that no funds, including federal funds, shall be expended to fill any position not authorized by the legislature; provided further that this prohibition shall not apply to:

- (1) The University of Hawai'i and the Hawai'i health systems corporation;
- (2) Positions entirely federally funded;

- (3) Positions established pursuant to section 76-16(b) subsections (3), (13), (21), and (23), Hawai'i Revised Statutes;
- (4) Where an agency has explicit statutory authorization to establish <u>new</u> positions to accomplish necessary functions; or
- (5) Temporary positions funded wholly or partially with federal funds from the American Recovery and Reinvestment Act of 2009;

provided further that with regard to any of the positions identified in paragraphs (1), (2), (3), (4), or (5), the respective agency or department shall submit a report to the legislature within ten days of each use of this provision; provided further that the report shall include:

- (1) Authority used to establish the position;
- (2) Date the position was established;
- (3) Projected date the position will be filled;
- (4) Amounts projected to be expended in fiscal year 2009-2010 and in fiscal year 2010-2011;
- (5) Source of funds used to pay for the position; and
- (6) Functions to be performed by the position;

and provided further that the department of budget and finance shall submit to the legislature a summary report of all uses of this proviso for the previous twelve month period from December 1 to November 30 no later than twenty days prior to the convening of the 2010 and 2011 regular sessions."

(11) By adding a new section to read as follows:

"SECTION 160.1. Provided that the University of Hawai'i shall prepare a detailed report on the sources of revenue for the research training and revolving fund, including the following information:

- (1) Purposes of the federal indirect overhead reimbursements;
- (2) A discussion on why reimbursements for overhead costs borne by the University and the general fund are directed to specific programs;
- (3) The basis for distribution formulas and discretionary distribution and parties involved in determining said distributions;
- (4) An analysis on how other universities in the Western Region utilize their indirect overhead funds;
- (5) Alternative methods of determining equitable and more transparent distributions of federal indirect overhead funds;
- (6) An analysis on how increased capital improvement expenditures can increase the federal indirect rate and estimates of the fiscal impacts to the University; and
- (7) Discussion on what level of reimbursements to the general fund would be appropriate for additional investments in capital improvements;

and provided further that the university shall submit the report to the legislature no later than twenty days prior to the convening of the 2011 regular session."
