INTRODUCTION

2010 saw the continuation and expansion of previous projects especially concerned with the futures of education, media, governance, and space, as well as the beginning of new projects concerned with energy and food self-sufficiency in Hawai‘i. With funds obtained from our research and training activities we were able to support four graduate students and host another visiting researcher from Korea. Among the highlights are these:

Locally, we continued phase two of “Campuses 2060”--a joint project with the University of Hawai‘i at Mānoa (UHM) School of Architecture, College of Education,

and Department of Political Science. We also began a similar project at the secondary school level. With the assistance of Dr. Phil Bossert of the Schools of the Future Project (Funded by the Hawaii Community Foundation) and Dr. Robert Witt, Director of the Hawaii Association of Independent Schools, ten of the schools that had been designated to become "Schools of the Future" responded to our offer of helping them develop curriculum and campuses focused on the futures (within a 2030 time frame) and not just the past and present. We eventually chose Kauai Pacific School. We have been helping them develop a new high school building and curriculum. We hope to expand this project to other schools, especially public schools.

We continued our series of talks and other activities throughout the community about energy, environmental, economic, governmental, and interrelated issues facing the community under the title, "Unholy Trinity, Plus One".

Most importantly in this regard, we partnered with Kanu Hawai'i in a project aimed at developing citizen awareness, information, and action about Hawaii's energy futures.

We are working with the Center for Global Nonkilling in developing a publication on "Futures of a Nonkilling World" as part of their multi-volume "Nonkilling World" series.

Nationally, the Center continues to work with state and federal judiciaries on judicial foresight, and with American colleges and universities interested in developing courses in futures studies. We consulted with the Federal Judicial Center and are actively engaged in futures of the courts project for the California State Judiciary in cooperation with the Institute for the Future of Menlo Park, California. We also developed the futures curriculum for the Command College of California, established by the State of California to train police chiefs and supervisors.

Internationally the Center continues to work closely with the international space community, and with the government of South Korea and related Korean research institutes on a variety of futures-related projects. We have signed an initial Memorandum of Understanding with JoongAng Media in Korea that will provide funds for the research and development of futures projects in various media, as well as their production and dissemination. We also are developing a series of Futures Workshops for Korean Journalists, funded by Samsung.

Our work on futures of higher education expanded this year to projects with the Ministry of Higher Education of Romania. With the Hague Institute for the Internationalisation of Law we also helped organize and facilitate a workshop this year at the Hague in the Netherlands planning for an international conference on "Futures of national law in a global society" to be held at the Hague in 2011. Finally we began work with the Finland Futures Research Centre, University of Turku, on a project titled "Past and future of futures research".

BACKGROUND OF THE CENTER

The HRCFS was established by the Hawai'i State Legislature in 1971 to collect and disseminate information about futures studies and to conduct futures research for public and private groups within the State, the region, and throughout the world (Chapter 304A-3253).

Locally, the HRCFS is administered by the UHM Department of Political Science. The HRCFS thus works closely with the Alternative Futures Graduate Option in the Department. The Alternative Futures Option, created in 1977, has produced scores of women and men who have gone on to become successful professional futures consultants in many fields, locally, nationally, and worldwide. The Alternative Futures Option was listed as Number 17 among the "100 Contributions" listed in celebration of the 100th Anniversary of the University of Hawai'i (*Malamalama*, Vol. 33, No. 2, May 2008, p. 4)

One component of the Alternative Futures Option is a paid internship that many students experience with the Institute for Alternative Futures (IAF), in Alexandria, Virginia (one of the oldest and most respected futures consulting firms in the world), with the HRCFS itself, or with some other futures consulting firm, such as the Long Now Foundation in California. Heather Frey interned at IAF this year, and Scott Yim and Rollie Ortiz anticipate interning there next year. A recent PhD graduate of the Alternative Futures Option this year became program director at another long-established futures consulting firms, the Institute for the Future in Menlo Park, California.

This year, as always, we consulted with several local groups in government, business and the nonprofit sector about various futures-oriented issues.

The HRCFS also cooperates with the Program in Public Administration, the School of Architecture, the College of Education and other University units on applied futures-oriented projects in Hawai'i and throughout the Asia-Pacific region.

Nationally, the HRCFS is a major futures resource. The HRCFS was responsible, with IAF, for the concept and development of "judicial foresight"--incorporating futures studies into judicial administrative decision-making. This began with work done by the HRCFS with Chief Justice William Richardson and Court Administrator Lester Cingcade of the Hawai'i State Judiciary from the 1970s onward. The State Justice Institute, a U.S. federal agency for state judiciaries, made the category "Futures and the Courts" one of its major funding categories specifically because of work done with and through the HRCFS and the IAF. Consequently, the HRCFS has engaged in judicial foresight activities indirectly with all, and directly with ten, other U.S. state judiciaries, as well as with the U. S. federal judiciary, many national and state bar associations, and with several foreign judiciaries and law-related entities, primarily in the Asia-Pacific. In addition, the HRCFS consults with many other governmental units, universities, businesses, religious organizations, and nonprofit entities throughout North America.

Globally, the World Futures Studies Federation (WFSF), the premier world organization of groups and individuals conducting futures research at a professional level, chose the Center to house the WFSF Secretariat during the 1980s and early 90s, and awarded the HRCFS its highest honor for excellence in futures research in 1995. The Center continues to work closely with the WFSF and with the Association of Professional Futurists.

The Center has been an Affiliate Campus of the International Space University (ISU) of Strasbourg, France since 1996. As such, UH faculty and students participate in the Masters in Space Studies (MSS) program at the main campus in Strasbourg and the nine-week Space Session Program (SSP) that is held in different locations around the world (most recently, the University of West Australia, Adelaide; the University of Bremen, Germany; Federico Santa Maria Technical University, Valparaiso, Chile; Suranaree University of Technology, Nakhon Ratchasima, Thailand; Beihang University, Beijing, China; Universitat Politècnica de Catalunya, Barcelona), and NASA Ames, California. SSP 2010 will be held at Graz University of Technology, Graz, Austria.

Similarly, selected ISU MSS students come to the Mānoa campus for their Internship Program. University of Hawai‘i students also enjoy special privileges regarding admission and substantially reduced tuition at ISU, and several UH graduates have studied at ISU under this arrangement. HRCFS and ISU also cooperate in various research, training and outreach projects, most recently in researching and writing a definitive book on space in all its human and scientific aspects titled, *The Farthest Shore: A 21st Century Guide to Space* (Apogee Books, 2010).
