# I. Purpose

- A. To recognize the importance of the University to protect the safety of its students, staff and faculty, and ensure the integrity of its academic processes.
- B. Establish systemwide student disciplinary sanctions.

# II. Definitions:

- A. Suspension: Suspension from the University of Hawaii for a specified period of time, after which the student is eligible to return. Conditions for readmission may be specified.
- B. Dismissal: Permanent dismissal of the student from the University of Hawaii.

# III. Executive Policy

- A. The safety of the University community and integrity of its academic standards are critical to the functioning of the University of Hawai`i. Students who have violated the University of Hawai`i campus student conduct code may be subject to additional systemwide disciplinary sanctions. A student suspended or dismissed from one campus may result in the student being ineligible to attend other campuses of the University of Hawai`i (systemwide sanction).
- B. A campus, upon conclusion of its student conduct code proceedings, may recommend sanctions including, but not limited to, suspension or dismissal resulting in the student being ineligible to attend all campuses of the University of Hawaii.

- C. The campus senior student affairs officer will forward the recommendation to the Associate Vice President for Student Affairs. The Associate Vice President for Student Affairs will review the recommendation that will include an opportunity for the student to present her/his case, if the student so desires, and consultation with other campus senior student affairs officers.
- D. Within five (5) working days of the conclusion of the review, the Associate Vice President for Student Affairs shall render the decision in writing to the student and the initiating campus.
- E. A "no cause" finding will result in no systemwide sanction. However, the individual campus sanction(s) will remain in effect.
- F. A "cause" finding will result in a systemwide sanction.
- G. Appeals shall be submitted in writing within five (5) working days of the decision. The Vice President for Academic Planning and Policy, or designee, shall review the case and issue a decision within ten (10) working days of receipt of the appeal. This decision will be final and binding within the University of Hawaii.
