SUBJECT: EUTF Enrollment Tips for Employees

Kaiser Permanente Hawaii Mental Health Professionals Strike

The EUTF Board of Trustees recognize issues EUTF members and their dependents are experiencing accessing mental and behavioral health services through Kaiser Permanente Hawaii (Kaiser) which have been impacted by the Kaiser mental health professionals strike since August 29, 2022. To address this issue, Kaiser members who are experiencing issues accessing mental and behavioral health services, may submit an appeal to change to an HMSA medical/CVS prescription drug plan (HMSA plan). Before submitting an appeal, please consider the following:

- If you decide to move to an HMSA plan, you and your dependents will all be moved to the selected HMSA plan. You and your dependents will have to find non-Kaiser primary care providers, specialists, pharmacists and other providers.
- No other plan changes are allowed such as adding or removing dependents or other plans.
- If approved, you will <u>not</u> have an opportunity to change back to Kaiser plans until the next Open Enrollment period, regardless of whether the strike is settled.
- The EUTF cannot guarantee better access or quality of care under a HMSA plan.
- If your premiums are deducted on a pre-tax basis, a change in premium pre-tax deductions will be contingent upon approval by your pre-tax benefit administrator. If it is **not** approved, you will continue to pay pre-tax Kaiser premiums, even if it is higher than the HMSA premiums, plus the difference (post-tax) between the higher HMSA premiums and the pre-tax Kaiser premiums through the pay period ending June 30, 2023.

Appeal forms must be postmarked or received (if via facsimile) to the EUTF by the earlier of June 30, 2023 or the end of the strike. The change will be effective as soon as administratively possible.
