Pursuant to APM Section A8.220, the Department requests a procurement exemption to purchase the following:

Description of goods, services, or construction:

Executive search firm services are being sought relating to the recruitment of a Director of the University Budget (System) for the University of Hawai'i (System). Search services shall include assistance in the recruitment, applicant pool administration, vetting, in-depth vetting of finalists to include background checks, and providing consultative assistance to the Search Advisory Committee and the Vice President for Budget and Finance/Chief Financial Officer. In addition, the Contract will provide general consultative services through completion of the search process.

Estimated Cost:

(1) Explanation describing how procurement by standard competitive means is either not practicable or not advantageous to the University;

Procurement by standard competitive means, including the preparation and advertising of a formal request for proposals, will not allow for the completion of the recruitment and selection process in a timely manner to permit the University to make offers of an appointment by the Fall 2011 to this key executive leadership position. As a reasonable alternative, it is being proposed that invitations be extended to firms that have successfully conducted executive searches resulting in executive placements and as a consequence have knowledge of executives that may have the potential to become viable candidates for the Director of the University Budget position. These services are similar to those provided by a professional services firm where a more informal process consisting of the review of statements of qualifications and the holding of discussions with prospective firms and individuals is advantageous.

(2) Details of the process or procedures to be followed in selecting the vendor to ensure as fair and open competition as practicable;

Potential executive search firms will be identified from a publicly available listing (attached). Informal requests for proposals will be forwarded to firms indicating experience in the conduct of executive searchers for administrative executive positions. Proposals received will be reviewed by the Search Advisory Committee. The Search Advisory Committee will identify up to 3 firms and forward to the Vice President for Budget and Finance/Chief Financial Officer based on an assessment of the firms' experience in: successful placements of executives in similar budget or financial affairs positions; successful placements of executives in large organizations or corporations; successful executive placements, if any, in public sector organizations, e.g., county government, University of Hawai'i, State of Hawai'i, the Judiciary; networking and outreach capabilities; administrative support capabilities; the ability to meet the search schedule set by the University; the proposed cost of the services to be provided; and the quality of the proposal.
