
(2) Explanation of the reasons that the amendment is necessary:

The Contractor is currently in the process of facilitating claimant meetings to discuss: 1) UHM's plan of action for consultation and repatriation, 2) current status of funerary objects, 3) requests for access to view object, 4) custody of object, and 5) process to consultation process to reach agreement on repatriation. Since the parties involved have not yet been able to reach an agreement regarding repatriation, additional claimant meetings are required.


