NOTICE TO EMPLOYEES ON PAYROLL TAX MATTERS FOR 2010

THE SOCIAL SECURITY WAGE BASE LIMIT FOR 2010 REMAINS AT \$106,800 (SAME AS 2009). THERE IS NO WAGE BASE LIMIT FOR MEDICARE TAX. THE TAX RATE WILL REMAIN 6.2% FOR SOCIAL SECURITY AND 1.45% FOR MEDICARE.

CHANGES TO THE FEDERAL INCOME TAX WITHHOLDING TABLES ARE REFLECTED IN YOUR FIRST JANUARY 2010 PAYCHECK. THERE ARE NO CHANGES TO THE STATE INCOME TAX WITHHOLDING TABLES.
