Game-Changer for Northeast Asia: Russian Energy Pipelines into North Korea & Japan

The construction of a commercially and politically viable oil & gas pipelines from (1) Russia's Siberian fields down through Russia's Sakhalin Island into Hokkaido, Japan and (2) also from Siberia down across North Korea to provide a long-term supply to South Korea and then from Busan across to Japan, has been given considerable attention by the media recently. This is a business deal that is at the confluence of international foreign policy and business. The project is a massive energy investment that is already underway with feasibility studies nearing completion. It may force regime changes in North Korea, partially replace Japan's aging nuclear infrastructure, and will necessarily transform the diplomacy and geopolitics of the Northeast Asia. With Japan now onboard with the TPP (Trans-Pacific Partnership) trade negotiations, the Russian energy pipelines will also effectively place Siberian energy resources within the coming Pacific free-trade zone should Japan elect to export the energy. Alternatively, this project will influence the diplomatic relationship between Russia and the United States, and may bring Russia into the TPP.
