## University of Hawaii Agreement Form for Use of SAS Software

The University of Hawai'i (UH) Information Technology Services (ITS) ("Licensee") has negotiated a site license contract with SAS Institute, Inc. ("Licensor") for the UH System. By purchasing this license through ITS, you agree to be bound by the terms of this agreement form, as well as the Licensor's end user license agreement ("Agreement"). If you do not agree to the terms of either Agreements, you must not install any SAS software obtained from the ITS Site License Office. Licensor may discontinue the license if the UH fails to comply with any of the terms and conditions of their Agreement.

This site license is in effect for a maximum period of one (1) year ending June 30 of the current UH fiscal year. Licenses can be renewed annually thereafter. Certain exceptions may apply for departments that fall under different terms. Unless otherwise specified, (1) license is valid for only a primary computer and can be installed on a secondary computer, as long as the program is used by the same user and only (1) computer is used at any given time. The Software may NOT be used outside the USA for a period of 90 days or more.

The AUTHORIZED USER ("USER") acknowledges that these products are copyrighted and that the Licensor retains all title and ownership rights to the products. The software may only be used only by designated, active USERs of UH and agrees they will **NOT COPY** nor permit others to copy any products under this Agreement, in whole or in part. Active UH faculty, staff and students include any student taking a UH credit course and faculty/staff currently employed or has direct affiliation with UH. Upon termination of employment or if advised by ITS that the contract with the Licensor has been terminated, all copies of the site licensed software obtained through the ITS site license office must be uninstalled. USER agrees to return to ITS all loan software in the USER's possession.

USER agrees to use the software under this agreement only on a computer which is owned or leased by the UH on campus or on a computer owned by the USER (home use by USER is permitted only if the Home-Use Agreement Form is submitted with payment). USERs of the site licensed software on UH owned or personally owned computers do so at their own risk. UH will not accept any responsibility or liability for any consequential damage or lost data resulting from the use of this software.

USER further agrees that the products must remain under their control, and that resale is explicitly prohibited. The license(s) may be transferred only with approval from the ITS Site License Administrator. USER also understands the usage rights of the license being purchased: "SAS Academic" Licenses are for UH related classroom, coursework and research use only and the "SAS Administrative" licenses are for UH non-classroom and non-research use. The software is NOT for commercial, time-sharing, rental, service bureau or any other outside use. The Software is copyrighted and contains trade secrets of the Institute. Title to the Software remains with the Institute at all times. In order to protect the Institute's trade secrets in the Software, users may not access the Software source code by reverse engineering, decompiling or any other means.
