SUBJECT: Consultation on Proposed Changes to EP 7.302 Preferred Name

Executive Policy 7.302 relating to a student's preferred name is currently under review by administration. After engaging in substantive informal consultation, the proposed policy changes are hereby being submitted for formal consultation. **Please consult with your constituents and governing bodies and provide any comments using the <u>online form</u> by March 24, 2023.**

Justification for Policy Changes

EP 7.302 provides guidelines for the use of a student's preferred name when their legal name is not required. This policy is being updated and expanded to facilitate a learning environment where all students are accepted and valued as part of an inclusive community by permitting the use of a student's chosen name, pronouns and gender identity when their legal name is not required.

Informal Consultation

Over the past several months, administration has engaged in informal consultation with a variety of individuals and groups across the System. These include providing draft copies of the policy revisions and receiving feedback from:

Key Changes at a Glance

- Adjusts the reference of "Preferred Name" to "Chosen Name" and adds the options for use of pronouns and gender identity.
- Clarification on where chosen name, pronouns and gender identity are allowable, including specification that a diploma is a ceremonial document that a chosen name can be printed on.
- Specifies that chosen name may be included as directory information.
