Your statement during the ACCFSC meeting that the intent isn't to crosslist courses from other campuses that overlap with the home campus's offerings was comforting. Also, if the crosslisted courses are going to be included in the home campus GPA of students, then I believe that there are more policy changes that would need to be enacted in order to clear the way for this type of crosslisting. Unless the courses are going to go through the curriculum process on the home campus, there seems to be a lot of problems that will arise. Knowing whether this curriculum process involvement will happen or not is going to be key in understanding how this initiative will play out. Just as an aside, I saw in the "Proposal" document that one of the points listed for justification includes an anecdote about an upset parent complaining to the President. This kind of evidence actually makes me (and probably other similarly-minded people) much less likely to support a proposal. I sincerely hope that isolated incidents like this one aren't major guides to the creation of policy at UH. That's especially the case because, based on my understanding of transfer, reverse transfer, and accreditation requirements, it seems that this incident is highly likely to be the result of a misunderstanding on the student/parent's part.
