UH Hilo	UH Hilo Faculty Congress			Thanks so much for the opportunity to provide feedback on the proposed revisions to RP 5.211. The UH Hilo Faculty Congress unanimously approved a motion to strongly recommend deleting 3.a, specifically the statement "In general, it is expected that the undergraduate admission requirements for UH Mānoa will be more stringent than for UH Hilo and UH West O'ahu" and avoid any language codifying comparative admission requirements. While we acknowledge that we may be likely to continue having less stringent undergraduate admission requirements than Manoa, we could see no benefit to including this language and discussed the potential harm from codifying what may be perceived as second-class status. The potential harms include diminishing our core undergraduate focus as a high quality small liberal arts university and harming the reputation of our niche graduate and professional programs. There were also concerns about lack of a definition for "stringent" and losing flexibility to adapt our admissions requirements to meet our mission.				Thank you for your comments.
