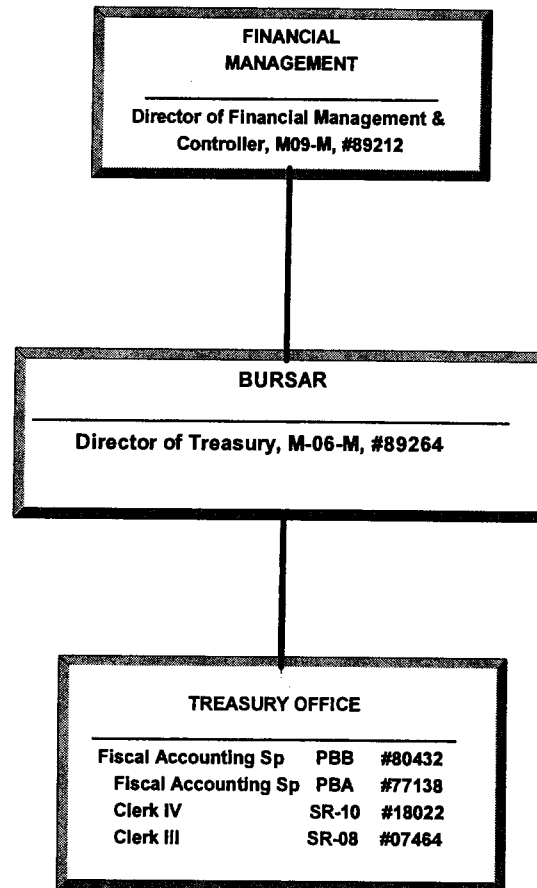

N = FEDERAL FUNDED POSITIONS

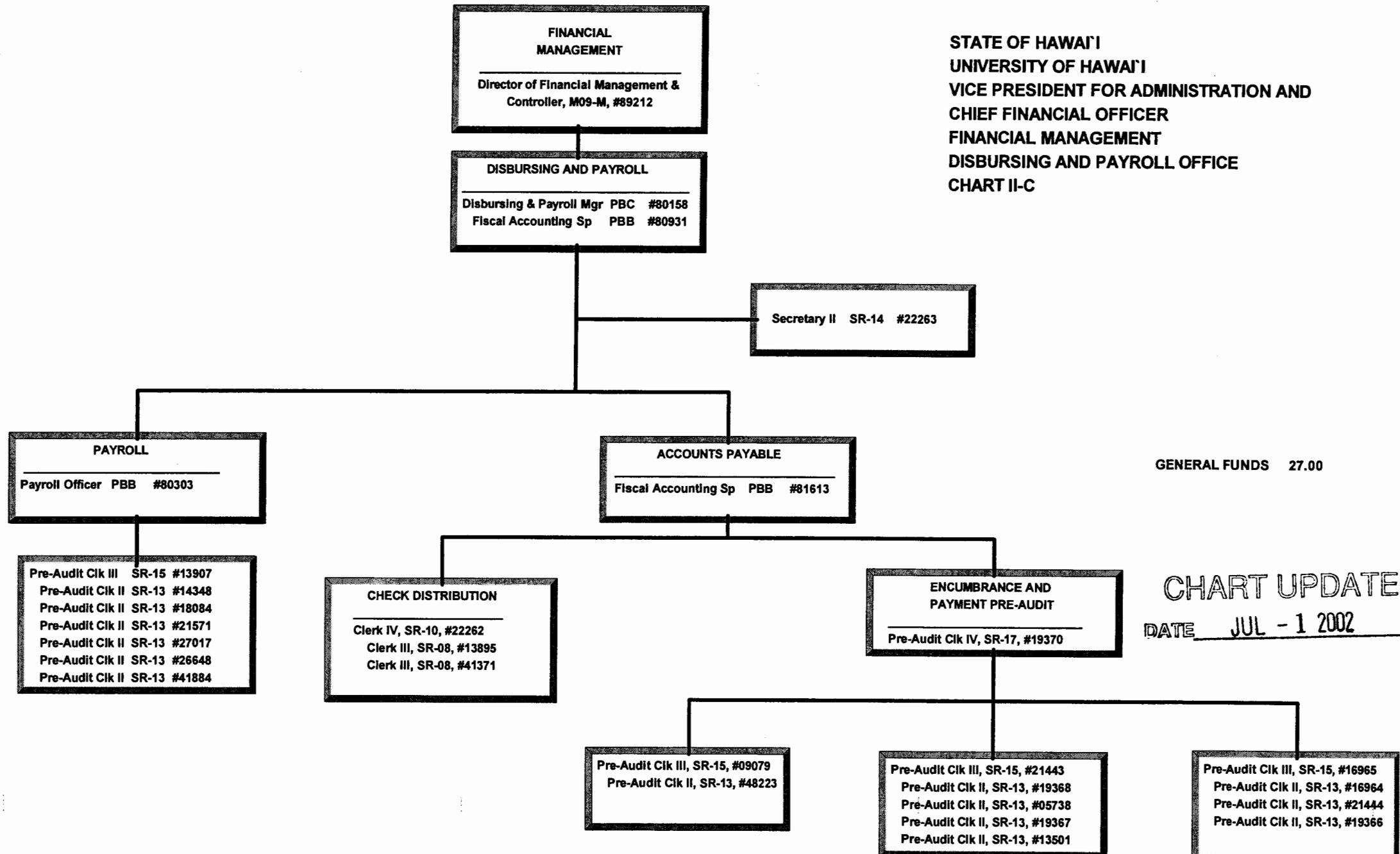

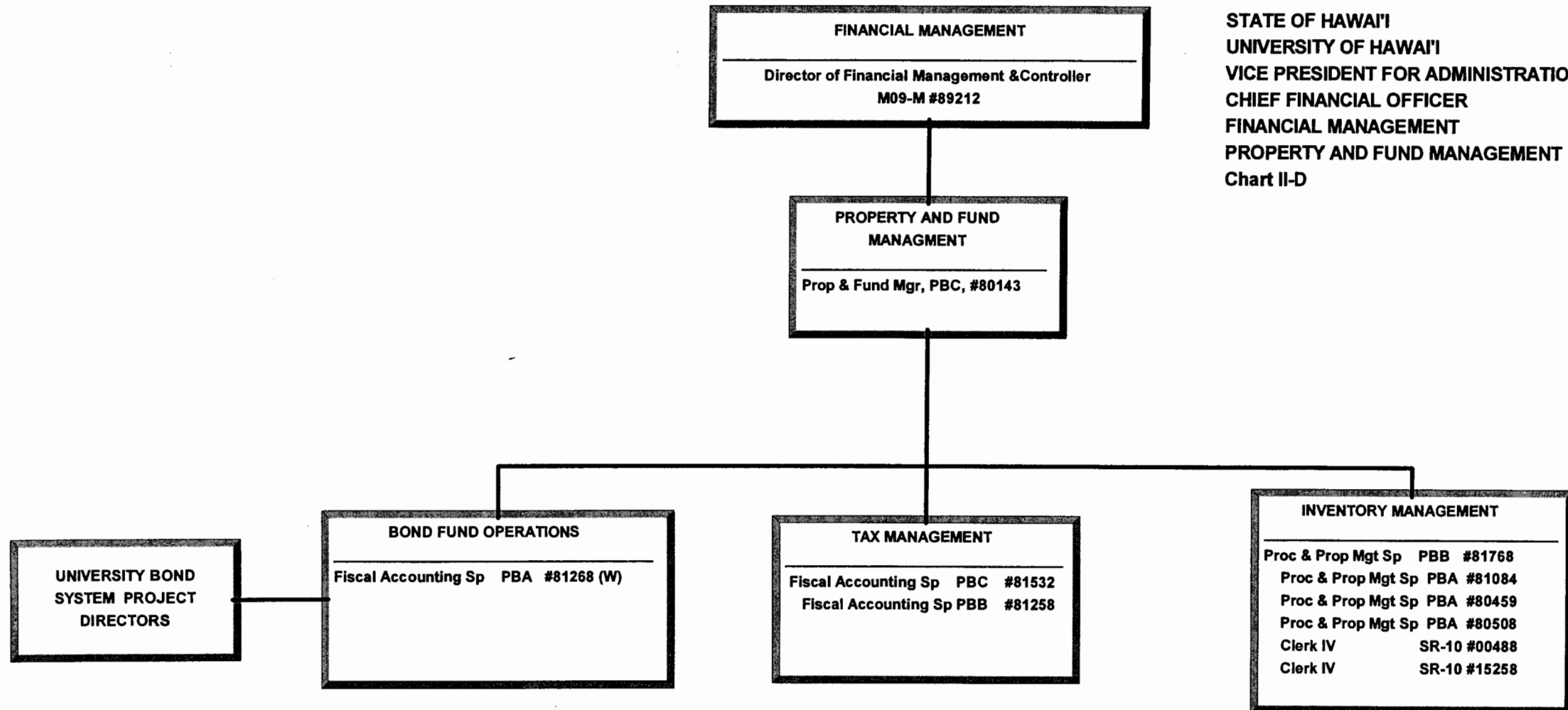

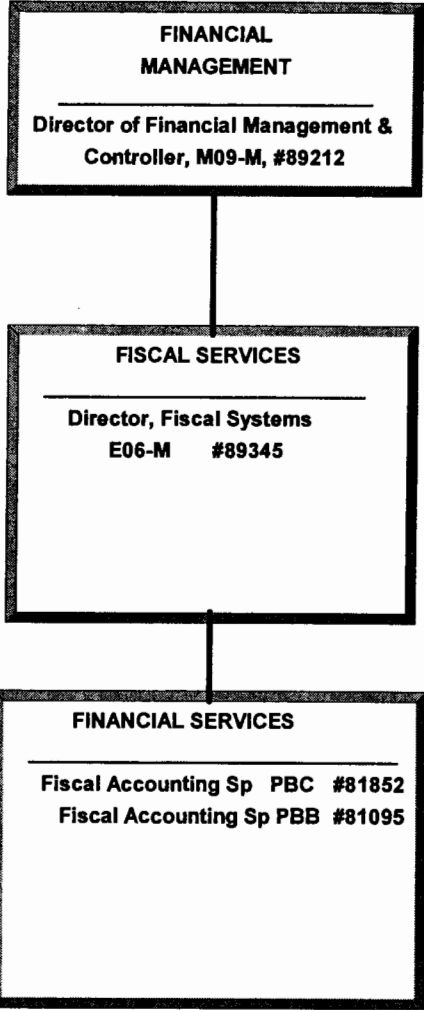

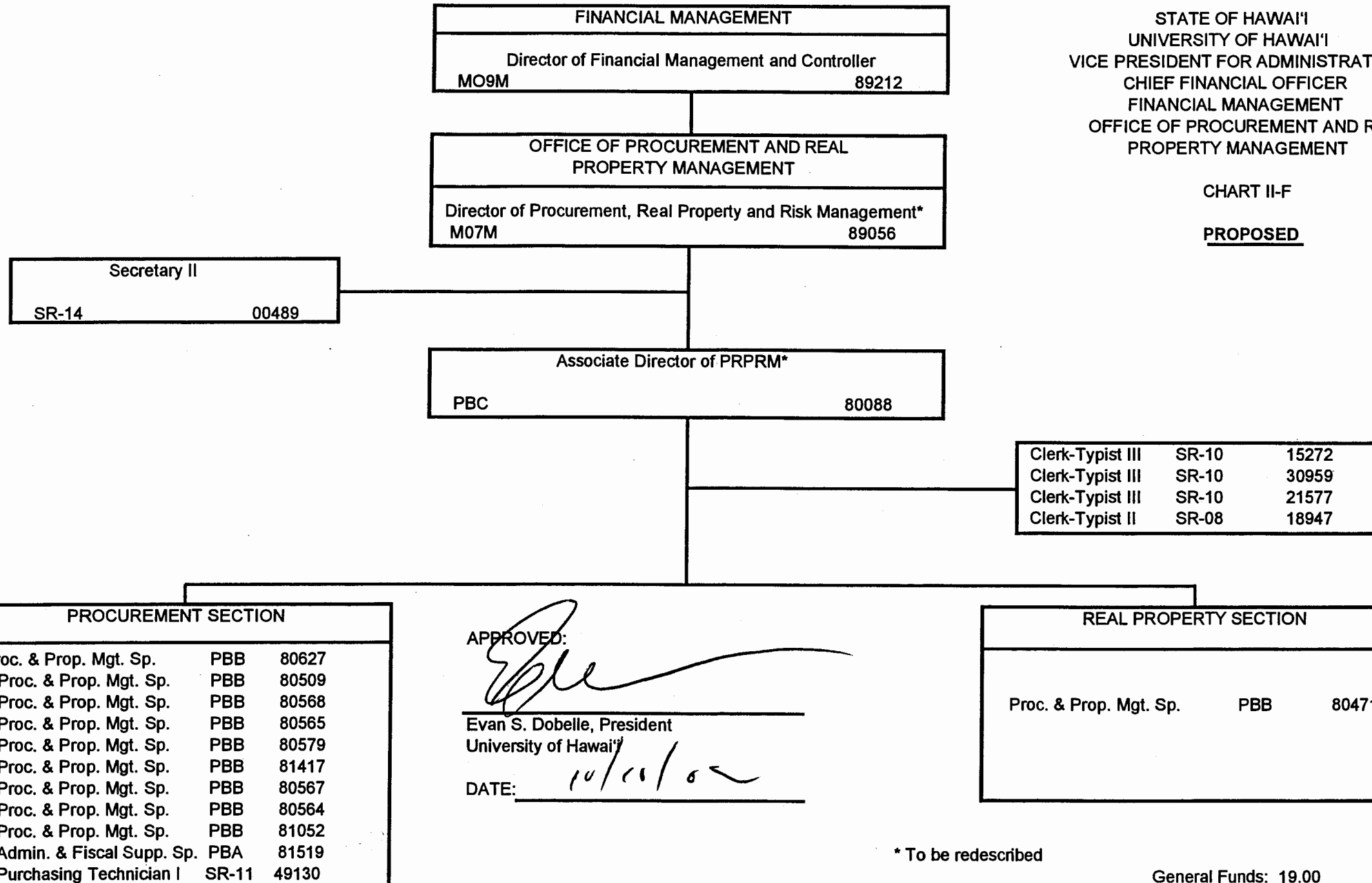

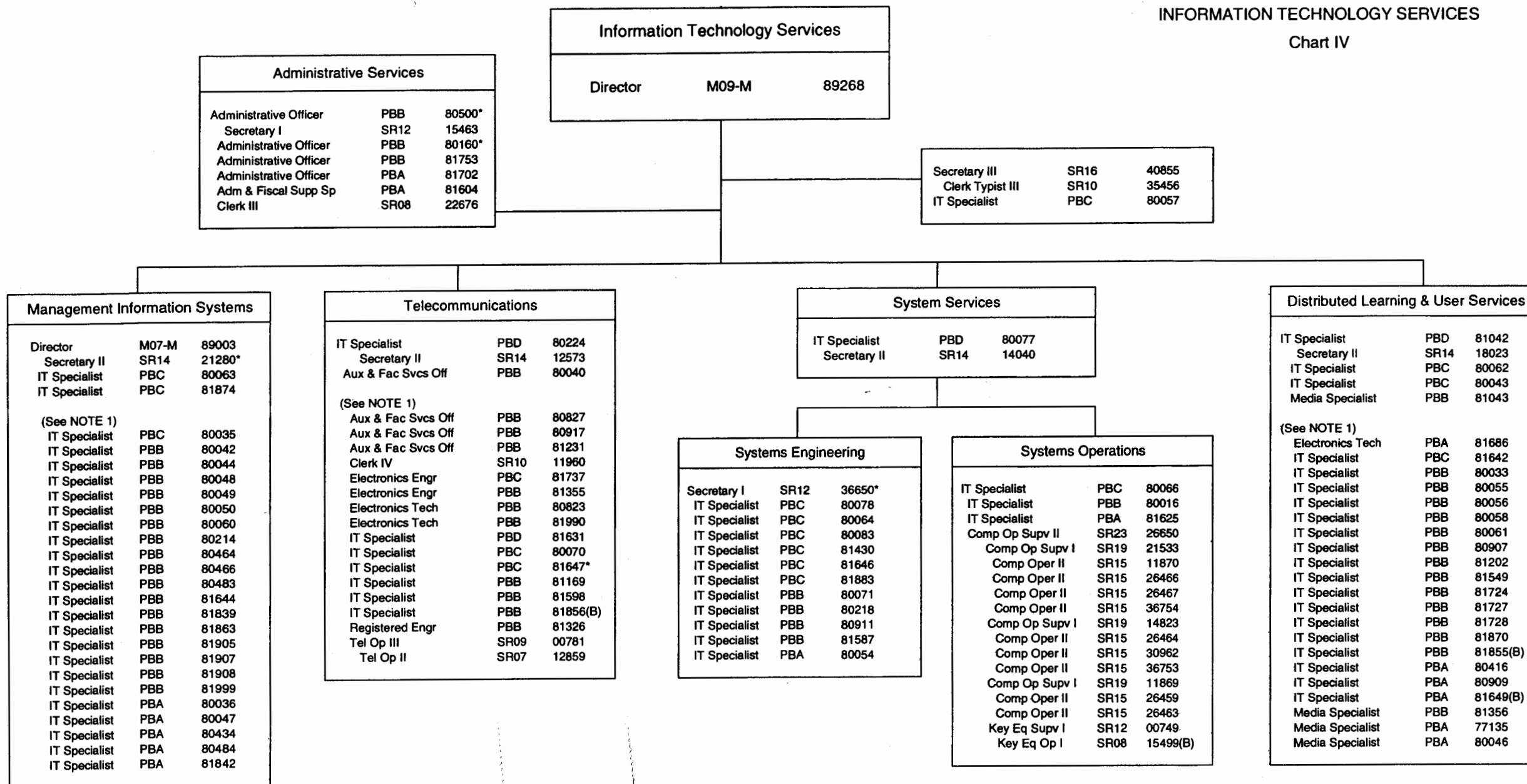

POSITION ORGANIZATION CHART V



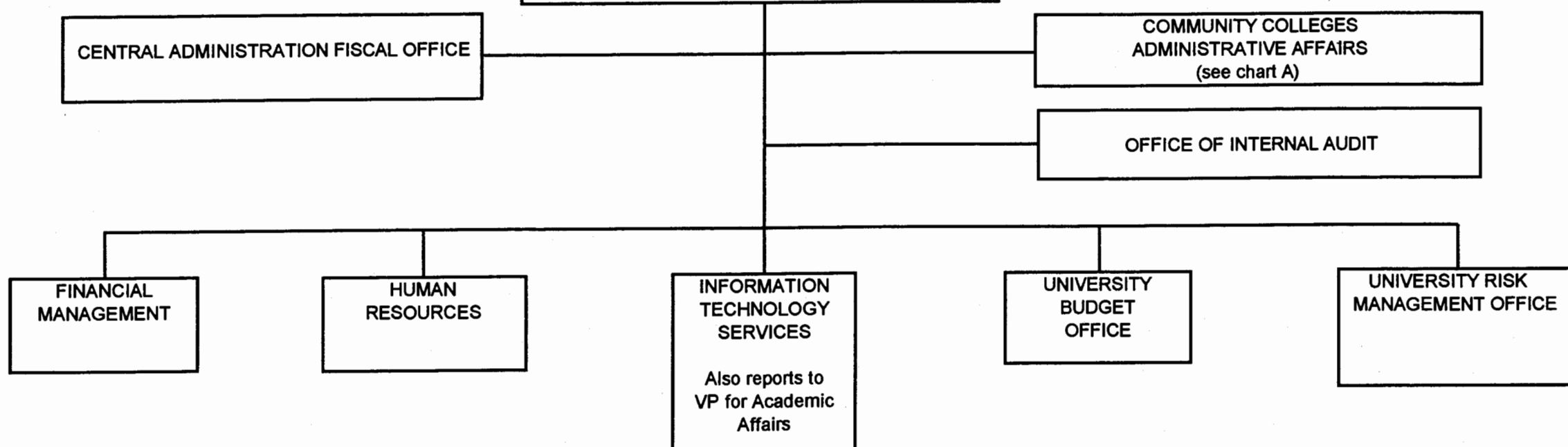
