# Reorganization Proposal College of Arts and Humanities, Department of History University of Hawai'i at Mānoa

#### **Executive Summary**

#### I. Purpose:

The purpose of this minor reorganization is to provide the Department of History ("Department") Chair with direct secretarial support by changing the supervisory level for the Secretary I position from the Associate Chair to the Chair of the Department.

#### II. Major Elements of the Proposal:

The Department of History is proposing to change the supervisory level for the Secretary I position from the Associate Chair to the Chair of the Department.

# Reorganization Proposal College of Arts and Humanities, Department of History University of Hawai'i at Mānoa

#### Narrative

#### I. INTRODUCTION:

A. Provide an overview of the College/School/Department and a snapshot outlining the current situation of the unit(s) involved in the reorganization.

The Department of History in the College of Arts and Humanities (College) at the University of Hawai'i at Mānoa offers degree programs at the BA, MA, and PhD levels and helps students develop skills in evaluating evidence, organizing information, clarifying concepts, and writing narratives. The geographical location of the UH Mānoa campus facilitates expertise in Asian, Hawaiian, Pacific, and World histories, as well as the American and European pasts.

With almost 30 full-time equivalent (FTE) positions, the Department of History has the most full-time faculty and is one of the biggest departments in the College.

B. Specify the objectives/goals of the new/restructured unit(s) involved in the reorganization.

The goal of this minor reorganization is to provide the Department Chair with direct secretarial support by changing the supervisory level for the Secretary I position from the Associate Chair to the Chair of the Department.

#### II. RATIONALE FOR THE REORGANIZATION:

A. Provide background and relevant historical information.

Historically, the Department had a Secretary II, Secretary I and an APT, Academic Support position, to provide administrative and academic support. The Secretary II and APT positions reported to the Chair while the Secretary I position reported to the Associate Chair. When the Secretary II position was vacated in 2008, the Chair had determined that the Secretary I and APT positions would suffice to provide administrative and academic support and therefore, the Secretary II position was no longer needed. The Department abolished the Secretary II position in December 2008. The Secretary I position continued to report to the Associate Chair.

To date, the position of the Secretary II has not been restored and the Department does not have a permanent position dedicated to providing direct secretarial support for the Chair. The Department has determined that it needs a permanent position dedicated to providing secretarial support to manage administrative tasks for the Chair. As of June 2014, the Secretary I position reporting to the Associate Chair of the Department has been providing

secretarial support for the Department Chair. The incumbent in the Secretary I position has been receiving appropriate temporary reallocation and remuneration for Secretary II level work performed.

B. Provide a detailed explanation of the conditions and/or factors prompting the proposed reorganization and how they will be addressed by the reorganization. Explain why the current organization is inadequate and whether the reorg is consistent with the University's strategic, program, and financial plans.

Since 2008, there have been numerous changes throughout the Department and the current need is for a Secretary II position to assist the Chair. The Secretary II will assist with maintaining the Chair's calendar, keeping abreast of and reminding students/faculty about departmental deadlines, drafting and reviewing correspondence on routine office inquiries, handling travel, conference arrangements, leave requests, retirement, and providing administrative services in all areas, including but not limited to, procurement, administration of extramural/intramural accounts/projects, budgets, personnel management, and curriculum/student management. The Secretary II position will be responsible for handling all administrative tasks as provided above so that the Chair may focus time and efforts on overseeing and improving faculty efforts in scholarship, instruction, and service; supervising and improving the faculty instruction; balancing instructional workload; overseeing the department budget and expenditures; and recommending academic appointments.

With almost 30 FTE, the Department is one of the biggest departments in College, yet is the only department under the College that does not have direct secretarial support for its Chair. The Department requires a permanent position dedicated to manage, coordinate, organize, facilitate, and provide a variety of services and supports to the Chair. The proposed organizational structure for the Department of History will be consistent with the organizational structure of several other departments within the College and provides essential administrative services and support for the Department Chair.

The Chair oversees the Department of History and the secretary serves as the extension to the Chair to help facilitate workflow, coordination and management controls and relationship with others. The Secretary II position will serve as the middle person between the faculty and the department and associate Chairs, between the department and the college, dean's office, and other campus department, and must be knowledgeable about the policies and procedures pertaining to personnel and fiscal matters.

The secretary will provide the Chair with administrative and secretarial support to submit reports on department expenses, handle travel, conference arrangements, and fiscal planning in a timely manner. The secretary will also assist in processing tenure and promotion, leave requests, retirement, and other personnel and fiscal tasks.

The current Chair, Associate Chair, and Secretary I have been informed of and are in strong support of the reorganization proposal.

Comment from the Department of History Chair: She recommends approval of the reorganization so the Chair's time and efforts may be more appropriately allocated to overseeing and improving faculty efforts in scholarship, instruction, and service; supervising and improving the faculty instruction; balancing instructional workload; and overseeing departmental budget and expenditures., and recommending academic appointments, rather than focusing on the administrative and secretarial support services that may be provided by the Secretary.

F. Outline the benefits that will be achieved by the reorganization, including efficiencies and service improvements. Explain whether the supervisor/subordinate reporting relationships are properly identified and how the reorganization will minimize confusion over authority, roles, and responsibilities.

Workflow will be more streamlined and operational efficiencies achieved with a Secretary II position reporting directly to the Chair. It would negatively impact the Department if there is no Secretary II position to oversee the work from the department as well as outgoing work to various campus departments, administrative processing will be at a standstill.

In addition, the Secretary I (also known as the Graduate Secretary) currently reports to the Associate Chair, but has also been assisting the Chair. If the Secretary would like to request vacation time off, that request has to be cleared by both the Chair and Associate Chair. This can result in confusion and/or duplication of communication and responses. This reorganizational proposal aims to promote operational efficiencies by decreasing instances of miscommunication and/or duplication of effort.

Current budget allocations will be used to cover the additional costs to redescribe the Secretary I to a Secretary II.

We will not ask for additional funding. We will be using funds allocated to the College.

From Current Chair: "Having the Secretary I position granted permanently would maintain that position in the future should there be a retirement or other change of staff. Also, it preserves the position of Chair in regards to authority for fiscal and other decisions made by the Secretary."

From Current Associate Chair: "Assuming that the Secretary II would continue to provide the same level of administrative support for the Graduate Program and Associate Chair, but would be reporting directly to the DC, then I think that I, as Associate Chair, would simply have to take more initiative in working with the Secretary II on Graduate Program issues."

#84415, Associate Professor and Chair. The Secretary II will report directly to the Chair.

Yes, there will be a change from the Secretary reporting to the Chair instead of the Associate Chair. This will streamline communication and the decision making process and also clarify the responsibility of the decision making process. The Secretary II may provide clerical assistance to other departmental staff as assigned. This also will permanently create opportunity for more collaboration of staff and have everyone work more effectively as a whole department.



RE: Reorganization Proposal for College of Arts and Humanities, Department of History

On June 7, 2018, a Reorganization Proposal from the College of Arts and Humanities was forwarded to the Manoa Faculty Senate Executive Committee (SEC) for appropriate consultation and action. This request was received during the Summer when many faculty are not on duty with a requested response deadline of July 25, 2018. Reorganization proposals should be submitted during the academic year for review by the Manoa Faculty Senate.

The SEC forwarded the proposal to the Committee on Administration and Budget (CAB) whose responsibility it is to review reorganization proposals and recommend appropriate action to the Manoa Faculty Senate via the SEC. Although CAB does not regularly meet in the Summer, CAB did their due diligence and reviewed the proposal, completed the appropriate review checklist, and recommended to the Manoa Faculty Senate that they endorse the proposal.

The normal process is that, following CAB's review, a resolution is developed for review by the Senate with Senators voting to support, or not support, the proposed reorganization. However, the full Manoa Faculty Senate does not meet during the summer unless there is an emergency, and the nature of this reorganization proposal, i.e., to move the reporting line for one secretary in the History Department from the Associate Department Chair to the Department Chair, did not, in the eyes of the SEC, merit the calling of a special session. The SEC does have the authority to act on behalf of the Senate during the Summer and decided to do so in this instance. On behalf of the Senate, the SEC, at its July 9, 2018 meeting, voted unanimously to endorse the proposal to move the Secretary I reporting line to the History Department Chair rather than the Associate Department Chair.

The SEC notes that the History Department will still need to reclassify the Secretary I position to a Secretary II position once the reorganization has been approved, with the requisite difference in funding to be internally covered by existing funds within the College. Please note that the SEC and the Senate have no authority over such matters. The Department and College will need to pursue appropriate procedures through Human Resources to resolve the reclassification issue. The SEC further assumes that secretarial duties related to the Graduate Program, currently overseen by the Associate Chair, will be addressed in the revised duties for the reclassified Secretary II. How these duties will be covered should be clearly noted in the request for the reclassified position.
